TERMS & CONDITIONS

1. The price of the afore mentioned packages include our normal coverage as per description in package. We shall supply enough dips and chocolate to feed the number of guests specified on this Contract.
2. Initial payment to secure services. A non-refundable or transferable payment £100 is charged when the client signs this contract and must be sent with the booking form to secure the date. Once received, a letter of confirmation and a receipt will be sent to you. Only once you have received your confirmation and your fee has been paid is your date secure. This payment is deducted from the package price. An invoice will be sent to you with your booking confirmation and must be paid two weeks before the hire date. Cheques payable to Kent Fountains or payment by credit/debit card (please phone with card number/details). Cheques returned unpaid by the bank will be charged to the clients account. If the client selects to pay their balance in instalments an agreement will be signed prior to commencement.
3. It is agreed that the terms set out in this booking form is the total agreement made between the parties and that no variation or modification of this contract shall be effective unless agreed by both parties in writing. All changes must be sent to Kent Fountains in writing as soon as they are made.
4. We will endeavour to supply all the dips requested. If for reasons beyond our control we cannot provide any of the agreed dips we reserve the right to substitute with a similar item.
5. Any special requests not notified on this booking form must be made by the client to Kent Fountains in writing at the time of final payment, 14 days prior to the hire date. It is the clients responsibility to inform Kent Fountains of any changes, times and locations written in this contract. Any information not known at the time of booking must be sent to Kent Fountains in writing as soon as the client has received the information. Any problems occurring due to lack of information or wrong information supplied by the client will be the responsibility of the client.
6. Copyright. Any images or copies of images whether stored digitally or otherwise and any computer program including any source or object code, computer files or printed documentation relating to such images are protected by the copyright and design act 1988. It is contrary to the Act to copy or allow to be copied photographically/electronically or by any other means an image created as part of this contract without the permission of Kent Fountains in writing. This contract allows you full use of the images . You may display or print them as you wish.
7. Negatives/Digital files remain the property of Kent Fountains.
8. Force Majeure or Act of God. The due performance of this contract is subject to alteration or cancellation owing to any cause beyond our control.
9. Display. The client hereby allows Kent Fountains to display any images included in this contract in their studio, portfolios, literature, wedding exhibitions, photographers website, magazines, newspapers and advertising. No use of the images will be made by the photographer for other commercial reason except with the written permission of the client. Please contact us in writing/email if you would prefer not to have your images used in this way.
10. Cancellation. Client may cancel this contract at any time by giving written notice to Kent Fountains but in doing so with forfeit any monies paid. Cheques returned unpaid by the bank will be charged to the clients account. The client will be liable to any additional expenses incurred due to cancellation. We recommend that the client invests in wedding insurance to cover any unforeseen eventuality.
11. Limitation of liability. In the unlikely event of a total equipment failure or cancellation of this contract by either party or in any other circumstance the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.
12. Complaints. Any complaints should be raised by the client to Kent Fountains in writing, within 28 days of first becoming aware of the matter to be complained of and in any event within 28 days of receipt of the images.
13. Hospitality. No food or drink are required by staff manning the Chocolate Fountains.
